DOG LICENSE INFORMATION AND NEW LICENSE APPLICATION

**ALL DOGS HARBORED IN THE TOWN ARE REQUIRED TO HAVE A LICENSE. FAILURE TO OBTAIN A LICENSE OR RENEW A LICENSE CAN RESULT IN A FINE. LATE RENEWALS MAY BE SUBJECT TO LATE SURCHARGE FEE.**

FEES: \$ 6.00 for Spayed and Neutered Dogs \$14.00 for Unspayed and Unneutered Dogs

RABIES VACCINATION: A current rabies vaccination is required for any license being issued or renewed. Copies of certificates are accepted.

NEW DOGS: If a dog has never been licensed, complete the section below, return with fee, proof of rabies vaccination, and a self-addressed stamped envelope for return of the license and the new tag.

RENEWALS: All licenses must be renewed each year and are due by the expiration date on that License Renewal form. Renewals will be mailed to residents. Make any necessary changes on the renewal form and return with fee, proof of current rabies vaccination if the vaccination has expired, and a self-addressed stamped envelope if you would like your paperwork returned. Failure to renew a license may result in a fine.

TAGS: All dogs will be issued one new tag with the name of our town and the dog's identification number on it when a new license is purchased. This tag is good for the life of the dog. Lost tags can be purchase for \$5.00. Any tags not bearing the name of the town are invalid and should be thrown out.

NO LONGER HAVE THE DOG: Complete the "License Change and Transfer of Ownership" section on the license renewal form and mail it to me, or just contact me by phone or email and let me know. If leaving a message or emailing, please give your name, name of dog, and reason for not having the dog.

PAYMENTS: Payments can be made by cash or checks. If paying by check, please make checks payable to Sandra Regan, Town Clerk.

MAILINGS: All mailings should be sent to me at the address above. Unless it is a new license, you will not receive any paperwork back unless you provide a self-addressed stamped envelope.
